

## Addenda 1 Callaway stadium & Field Lighting Project

1. . I wanted to follow up on a few questions that were posed during the walk through. Were a looking for the electrical drawings well as the question about how far down the pole bases need to be removed.

**NO electrical drawings/plans (or electrical "as-built" drawings/plans ) have been located to date.**

**Please demo and remove the existing light pole foundations (including light poles) one foot (1'-0") below existing finish grade, then backfill to surrounding finish grade. Also, terminate and remove the existing electrical supply, per the same required specification.**

2. Can you confirm if there an opportunity to submit equivalent LED fixtures for review and pre-approval? Or will proposed fixtures be evaluated and approved after bid opening?

**Please review the entire "Invitation To Bid", "Proposal Form", and RFP documents; which specify the exact requirements of the Sealed Proposals and a detailed project proposal demonstrating the proposed lighting system design and compliance with the Scope of Work.**

3 . I am reaching out in regards to bid, ***Callaway Stadium & Field Lighting Project***. Can you please provide the following information regarding the existing lighting?

1. Voltage and Wattage of existing lights
2. Height of existing pole
